The Commonwealth of Kentucky, Transportation Cabinet, Department of Highways requested an aerial easement over CSR property for the improvement of Stringtown Road in Grant County, Kentucky. The Cincinnati, New Orleans and Texas Pacific Railway Company (CNO&TP) reviewed the request and determined that such sale would create uneconomic remnants of two adjacent parcels and required their inclusion in this sale. Ms. Carman passed out proposed Resolution 1-2012 that authorizes Mr. VanderLaan to execute any and all documents on behalf of the Board to effect a transfer of the aerial easement and two parcels to the Commonwealth of Kentucky, Transportation Cabinet, Department of Highways.
