Kilcoyne, McOwen, Sylvester, and VanderLaan. Ms. Carman, Assistant City Solicitor, was also present.

SWEARING IN OF THOMAS McOWEN AS TRUSTEE.

Mr. Thomas McOwen was sworn in as the newest member of the Board of Trustees by Ms. Carman. Mr. McOwen was appointed to fill the unexpired term of Nick Vehr. His term is set to expire July 25, 2008.

MINUTES OF THE PREVIOUS MEETING

Ms. Carman handed out the minutes from the February 17, 2005, meeting. Mr. Sylvester moved to approve the minutes. Mr. Kilcoyne seconded. Unanimously approved.

SALE OF PROPERTY IN LEXINGTON, FAYETTE COUNTY, KENTUCKY

Mr. Thomas Ambler, attorney for the Norfolk Southern, forwarded to Ms. Carman information concerning the request of the Kentucky Transportation Cabinet (KTC) to purchase, in lieu of condemnation, certain easements from the CSR and CNO&TP. KTC offered to pay a total of \$16,300 for two permanent easements and two temporary construction easements. NS reviewed the appraisal supplied by KTC and found the offered price to be reasonable. \$8,525 for the two permanent easements will be

deposited into the 3(f) account. CNO&TP will retain the \$7.775 for the temporary easements as lease-type payments. Mr. Kilcoyne moved to approve the sale. Mr. Sylvester seconded. Unanimously approved.

MINUTES OF THE PREVIOUS MEETING

SALE OF PROPERTY IN HELENWOOD, SCOTT COUNTY, TENNESSEE

Mr. Thomas Ambler, attorney for the Norfolk Southern, forwarded to Ms. Carman information concerning the request of the Kentucky and Tennessee Railway Company to purchase 3.3 miles of line which the Trustees had previously consented to an abandonment of. K& T offered to pay a total of \$136,572 for the track and line, which was the value placed on the track and line by an appraisal secured jointly by NS and K& T. After discussion, the Trustees decided Mr. McOwen would discuss the appraisal with someone from NS. Ms. Carman will contact Mr. Ambler to get an appropriate name and phone number for Mr. McOwen.

ANNUAL MEETING

The Trustees agreed that the suggested date of December 13, 2005, was, for them, the best date for the annual meeting. Ms. Carman will contact Mr. Ambler with that

information.

SAFE

Ms. Carman will contact Mr. Ambler to tell him that the Trustees' safe can be moved to NS's Queensgate office.

GEORGIA REGIONAL TRANSPORTATION AUTHORITY

The GRTA owns a line from Chattanooga to Atlanta. In June, Ms. Carman received a letter from Crew Heimer of GRTA expressing an interest in possibly pairing with the City at the time both the CSR and GRTA leases expire. Mr. McOwen will draft a letter to Mr. Heimer's supervisor for Mr. VanderLaan's signature that acknowledged the Trustees' interest in Mr. Heimer's suggestion.

HIGH SPEED CORRIDOR

Mr. McOwen will investigate the high speed corridor situation and report back to the Trustees.

Ms. Carman will arrange a time in November for the next quarterly meeting.
